When you go to the office here is what you want to say:

<If they say they will see if they are available, then have a seat, and be prepared to tell your story, ask that they consider co-sponsoring the legislation, and voting in favor of paying our Americas Coast Guard, when the bill comes forward for a vote.>

<If they say no, ask if you can leave the letters for them to review when they get time, because the Executives of Sea Service Family, Foundation and Chief Petter Officers Association will be in touch with their office in the next 48 hours. Before you leave ask for the contact information for the staffer who deals with Coast Guard Issues.>

<If the office is already signed onto the legislation simply ask to speak to the staffer in charge of USCG so you can thank them, and give them a package!>
